

WHAT does the library have for 5<sup>th</sup> & 6<sup>th</sup> grade students? KINDLE e-Readers

WHO may borrow one? Your child may check one out for 1 week at a time.

BOOKS – The Library will have 45 titles for your child to “check out” on a KINDLE available during the first week of February.

The KINDLES will be checked out on a first come, first serve basis. The first students to return their Borrowing Agreement and are showing adequate Accelerated Reader progress will be the first to check out a KINDLE.

#### HOW DO I DO THIS?

1. Your child will bring home a permission slip or you may print one off from [www.rrcnet.org](http://www.rrcnet.org).
2. A parent/guardian must sign permission slip along with the child.
3. Return permission slip to Mrs. Hubert
